Monday, August 27, 2018, was a long, but rewarding day for Sun City Elk Lodge Members. The day began, as usual, with the Sun City Elks picking up furniture, from gracious Elk members, who greatfully donate, to the welfare of our veterans.

After spending the morning, defying the summer heat in Arizona, the Sun City Elks made a trek to the Arizona State Veterans home, to put on their monthly bingo event there.

Twenty one (21) vets (a smaller number then usual), thirteen Elk members and Two (2) volunteers attended the bingo party, which is put on in an effort to bring some cheer to the residents there.

As usual, every vet won and every vet left with a little more money in his/her pocket, to spend at the facilities commissary.

In addition to the bingo party, for the second month in a row, the "Quilts of Love" group, based in the Arizona Traditions community in Surprise, Arizona, donated "Quilts of Love", to those vets unable to attend the bingo event. Needless to say, it was a great day thus far, but far from over.

# Choosing a Continuing-Care Retirement Community

Can you give me some tips on picking an all-inclusive residential retirement community that offers independent housing, along with assisted living and nursing care? My husband and I are looking to downsize and simplify, but we want our next move to be our last.

If you want your next move to be your final one, an all-inclusive retirement community — also known as a continuing-care retirement community (CCRC) — is a great option to consider.

CCRCs are different from other types of senior housing because they provide all levels of housing, services and care in one convenient location. While they vary greatly in appearance and services, most CCRCs offer apartments or single-family homes for active independent seniors. They also offer onsite assisted living for seniors who require help with basic living tasks like bathing, dressing or going to the bathroom and nursing home care for residents who are in declining health.

CCRCs also provide a bevy of resort-style amenities and services that include community dining halls, exercise facilities, housekeeping and transportation, as well as many social and recreational activities. Be aware that these services often come at a hefty price. Most communities have entry fees that range from the low to mid-six figures plus ongoing monthly fees that can range from around \$2,000 to over \$4,000 depending on the facility, services and the contract option you choose.

With more than 2,000 CCRCs in operation throughout the U.S., finding a facility that fits your lifestyle, needs and budget will require some legwork. Here are some steps to help you proceed.

**Make a list:** Start by calling the Area Agency on Aging (call 800-677-1116 for contact information) in the area you want to live for a list of CCRCs.

Call the facilities: Once you have located a few local facilities, call them to find out if they have any vacancies, what they charge and if they provide the types of services you want or need.

**Take a tour:** Many CCRCs encourage potential residents to stay overnight and have a few meals in their dining hall. During your visit, notice the upkeep of the facility and talk to the current residents to see how they like living there. Also, check out the assisted living and nursing facilities and find out how decisions are made to move residents from one level of care to another.

To learn more about a facility, call the state long-term care ombudsman (see LTCombudsman.org) who can tell you whether the assisted living and nursing care services within the CCRC have had any complaints or other problems. You can also use Medicare's nursing home compare tool at Medicare.gov/nursinghomecompare.

**Review contracts and fees:** Most CCRCs offer three types of contracts: Type A, or life-care contracts, which have the highest entry fee but cover all levels of long-term care as needed; Type B, or modified contracts, which have lower entry fees but limit long-term care services in the initial fee; and Type C, or fee-for-service contracts, which offer the lowest entrance fees but require you to pay extra for long-term care if you need it.

You also need to find out what yearly price increases you can expect. You should also inquire as to how much of your entry fee is refundable if you move or die and what happens if you outlive your financial resources.

**Research the CCRC:** Find out who owns the facility, get a copy of their most recently audited financial statement and a copy of their contract and review these with your lawyer or financial advisor. You should also request information regarding their occupancy rate. Unless it is a newer community filling up, occupancy below 85% could be a red flag that the facility is having financial or management problems.



#### Aretha Franklin's Estate Faces Challenges

On August 31, 2018, musicians, actors, religious leaders and politicians gathered at Detroit's Greater Grace Temple to remember and celebrate the life of Aretha Franklin. Ms. Franklin passed away at age 76 without a will.

Los Angeles attorney Don Wilson represented Franklin throughout her music career. On several occasions, he urged her to complete a will and living trust but she did not create an estate plan.

Wilson stated, "It would have expedited things and kept them out of probate and kept things private. I just hope her estate doesn't end up getting so hotly contested. Any time they do not leave a trust or will, there always ends up being a fight."

Franklin's four sons filed documents with the Oakland County probate court and indicated they were "interested persons." One of her sons, Kecalf Cunningham, noted in the filing that Aretha Franklin "died intestate."

The probate process is now proceeding in Oakland County, Michigan. Franklin owned three homes in Bloomfield Township, Michigan and one home in Detroit. However, the primary value of her estate is her intellectual property. This property includes many recordings, musical compositions and her likeness.

Franklin was extremely successful and was called the "Queen of Soul." She had over 100 single recordings on the Billboard charts and received 18 Grammy Awards. Her estate property value could be in the tens, or even hundreds, of millions of dollars.

When Michael Jackson passed away, his estate executors claimed that the estate was only worth a few thousand dollars. However, IRS appraisers valued the estate at \$1.1 billion. Understandably, the estate is interested in keeping the valuation low to reduce estate tax while the IRS seeks a large value in order to increase the estate tax.

Because the Franklin estate is likely valued over the 2018 exemption of \$11.18 million and valuation of intellectual property is quite difficult, the four sons are likely to be in a contentious dispute over valuation with the IRS. The valuation contest with the IRS can proceed through the tax and appellate courts for a decade or longer.

**Editor's Note:** Franklin's four sons will likely receive creditor claims, contest the estate value with the IRS and negotiate multiple contracts and licenses for Franklin's intellectual property. This process is particularly difficult because there is no will and the property will pass to heirs under Michigan law. Therefore, it may be several years before the Oakland County Probate Court determines the specific shares of ownership for the four sons or other family members. With many millions of dollars in estate value, and millions more owed to the IRS for estate taxes, the potential for intense and protracted conflict is great. A will and living trust by Ms. Franklin could have saved enormous costs and enhanced family harmony.
