# Sun City Elks Initiate 44 New Members

# **Helping Seniors Extend Their Driving Years**

What tips or resources can you recommend to help seniors extend their driving years? My dad, who is 82, is still a decent driver, but I worry about his safety going forward.

With more than 40 million licensed drivers in the U.S. over the age of 65, there are many resources available today to help keep older drivers safe and behind the wheel longer. Here are some simple steps you can take to help keep your dad driving safely.

**Get his eyes checked:** Because about 90% of the information necessary to drive is received through our eyes, getting your dad's eyes checked every year to be sure his vision and eyewear is up to par is an important first step.

**Check his meds:** Does your dad take any medicine or combination of medicines that make him sleepy, light-headed or loopy? If so, make a list of all his medications (prescription and over-the-counter) and dietary supplements and take it to his doctor or pharmacist for review. You can also get help with this online at *RoadwiseRX.com*.

**Evaluate his driving:** To stay on top of any potential driving issues, you should take a ride with your dad from time-to-time and watch for problem areas. While you observe, ask yourself: Does he drive at inappropriate speeds, tailgate or drift between lanes? Does he have difficulty seeing, backing up or changing lanes? Does he react slowly, get confused easily or make poor driving decisions? For more tips, see the National Caregivers Library driving assessment checklist at *SeniorDriverChecklist.org*.

If your dad needs a more thorough evaluation, you can turn to a driver rehabilitation specialist who is trained to evaluate older drivers. This type of assessment typically costs between \$100 and \$200. To locate a professional in your area, visit *AOTA.org/older-driver* or *ADED.net*.

**Take a refresher course:** AAA and AARP both have older driver refresher courses that can help your dad tune-up his driving skills and learn how to adjust for slower reflexes, weaker vision and other age-related changes that affect driving. Taking a class may also earn him a discount on his auto insurance. To locate a class, contact your local AAA or AARP. Most courses cost around \$15 to \$30 and can be taken in the classroom or online.

Another good resource to look into is CarFit. This is a free assessment program that will help your dad adjust his vehicle for a better fit, making it easier and safer to drive. CarFit events are held around the country in select locations. See *CarFit.org* to look for one near you.

**Make some adjustments:** Recognizing your dad's driving vulnerabilities and making small changes to when and where he drives can go a long way to help keep him safe and driving longer. Adjustments may include not driving after dark or during rush hour traffic, avoiding major highways or other busy roads and not driving in poor weather conditions.

When it gets to the point that your dad's driving is not safe anymore and he needs to step away from the wheel, The Hartford Financial Services Group and MIT AgeLab offers two helpful resources. Visit The Hartford's website and click on "Publications" to download or order the "At the Crossroads" and "We Need to Talk" guides.

Dan is not an Elk member, but reached out to the Sun City Elks, to help him in his quest, as he was permanently leaving the state, but wanted to leave a gift behind.

The gift, a 2007, red, Chevy Impala.

Dan could have sold the vehicle, but instead, chose to donate it to a Vet, who might just be able to use a vehicle.

The exchange had to be done immediately, as Dan was leaving our fair state on Monday, March 11, 2019.

Not sure of how to accomplish this, Dan approached members of the Sun City West auto restoration club, to ask for assistance.

No one at the restoration club knew of a Vet in need of a vehicle, but did know of a person and an organization that would be able to help him.

The person and organization?

Gary Drumheller and the Sun City Elks Veterans Committee.

Dan contacted Gary on Friday, March 8,2019, Gary contacted the US Vets Facility at 3400 W. Grand Ave. that same day and asked if they could use a vehicle. On Saturday March 9, 2019, the exchange was made.

The recipient of the cherry red Impala is himself an Army Viet Nam Vet., Pedro Alves, a resident of the Grand Avenue facility.

One Viet Nam Vet helping another Viet Nam Vet, Dan's wishes could not have been better.

Pedro, has been assisting other Vets for several years, helping them find clothes and dress properly, when auditioning for a job, unfortunately, he was presently without a means of transportation, so his ability to aide other vets fell by the way-side, unless they lived in his facility.

Pedro in normally a quiet taciturn individual, but on this day he was even more so, his expression, on being given the vehicle,"unbelievable".

#### Casino Night Fund Raiser



A recent fund raising event was held at the Sun City Elks a Lodge located at 10760 W. Union Hills DR. to help raise funds to send their Veterans to Washington D.C. on the Memorable "Honor Flight Program".

The lodge has already sent over seventy members on this flight to honor their sacrifices.

Approximately thirty seven (37) WW11 vets and approximately forty (40) Korean Ware vets have already made this flight and the lodge is seeking to send each and every lodge Vet, capable of making the flight, the opportunity to go.

Most WW11 and Korean War lodge Vets have already made the flight and the lodge is beginning to enroll it's Viet Nam Vets at this Time, but as new Vets from the previous wars pop up, they

will be given priority.

It costs the lodge \$1,150 to send each Vet on the trip.

The event in question was a "Casino Night" gala that saw over 150 members and guests attend.

The lodge raised in excess of \$3500, allowing the lodge to send 3 more Vets to Washington and still have a few dollars to spend on other Vets programs.

One such program is providing power wheel chairs and power scooters to Vets in need of them.

Elk members and friends donate the various chairs and scooters and the Sun City Elks take these items to the Southwest Mobility store at 15458 N. 99<sup>th</sup>. Ave. in Sun City for repair and upgrading.

Southwest mobility only charges the Elks for any parts required, but does all of the maintenance free of charge to the Elks, as their contribution to our Vets.

The money for the parts, plus food, clothing, bedding and appliances the Elks provide, come from its various fund raisers, and individual donations.

The entire Elks Organization, consider it their duty and responsibility, to assist our Vets in any way possible and work diligently to that end, living up to it's motto, "that as long as there are Veterans, they will never be forgotten".



gers of drug abuse. The students received Drug Prevention information packets to take home.


