Tucson East 2532 used their Gratitude Grant and other funds to provide backpacks to homeless veterans during the Veterans Standdown that was held March 9th through the 13th. Each of our fabulous backpacks contained multiple t-shirts and undergarments, sunscreen, hats, water bottles, rain gear, a flashlight with extra batteries, deodorant, razors, shampoo, soap, a couple of washcloths and Chapstick and wet wipes.

The first two days of the Standdown consisted of setting up the space at the Luxe Hotel and sorting the clothes, hygiene items, shoes and pet supplies that had been donated by partner agencies and the community at large. Since we were there from day one, we were asked not only to give out our pre-stuffed backpacks, but to also man the hygiene day and hand out those supplies too.



When we finally opened for the veterans on day three it was inspiring. In addition to the clothing, shoes, hygiene and pet area, there was a haircut area, veteran’s court area, meals, bus passes, housing and a section filled with service vendors willing to give a helping hand. We ran out of some items the first day, but a quick trip to the dollar store replenished our dwindling supplies and we were ready for the next day of serving our veterans. On day four a job fair was added for those interested in seeking employment. Towards the end of day four we started packing up and breaking down the space and day five was a continuation of that process. Once everything was packed up it was into the trucks and back to storage.

We can honestly say while tired we felt grateful for the many things we have in our lives and truly Blessed that we were able to help so many in need. A Message from Grand Exalted Ruler Robert L. Duitsman

All,

Various Local Lodges are requesting information pertaining to being open or closed. As a reminder, Local Subordinate Lodges are Chartered under the 501(c)(8) umbrella of the Grand Lodge and governed by the Constitution, Statutes and Laws of the Order.

The day to day operations are overseen by the Lodge Officers, the House Committee and membership as governed by said Constitution, Statutes and Laws of the Order as well as complying with local, county, state and federal laws, executive orders, mandates, rules and ordinances. Of which, most are different for each Lodge or Lodge location. In instances of this nature, Local Lodges must also comply with any local, county, state and federal public health mandates, directives and announcements as well as using common sense during these trying times.

Attached are suggested recommendations (<https://www.elks.org/members/NewsStory.cfm?StoryID=122184>) for the Local Lodges to follow and offer guidance on other items. ***For further guidance, assistance and direction, please contact your State Sponsor.***

Grand Lodge hopes each Local Lodge and State Association has implemented the following CDC guidelines on practical ways to prevent the spread of infection:

1. No shaking hands, hugging, knuckle bumps or high fives.
2. Keep a safe distance from others. Six feet when possible.
3. Wash hands often with soap and water for at least 20 seconds.
4. No soap? Use hand sanitizer (60–95% alcohol based).
5. Avoid touching your face, eyes, nose, and mouth.
6. Cover your cough or sneeze into the bend of your elbow or a tissue, then throw the tissue in the trash.
7. Stay home when you are sick and avoid close contact with people who are sick. Encourage others to do the same.

We all need to keep in mind that the health of our Members, spouses, significant others, friends, volunteers and employees is paramount. Let's be vigilant in our efforts to keep one another healthy!

“Grand Lodge COVID-19 Recommendations”

CORONAVIRUS GUIDELINES FOR THE B.P.O.E.

Grand Lodge Advisory Committee recently held a conference call to discuss the coronavirus issue and how Lodges should proceed during this unprecedented health crisis. They offer the following guidelines that may be applied to all of our Lodges in every State. Items listed below are a guide for each State Sponsor so he can establish further guidelines for the State Associations and Local Lodges he oversees.

Since every State, and even localities within a State, are issuing different guidelines on activities and closures, the Advisory Committee determined that restrictions/limitations regarding the virus should be left to each State Sponsor and that the Lodges should follow their State government directives, along with local and state health official guidelines, as overseen, encouraged and/or directed by the State Sponsors. An example of the differences is that some states have closed bars and restaurants, others have not ordered closures, but most all are limiting gatherings to groups of no more than 50, 25, 20, 10 or even 4 persons, depending on the Federal, State and Local mandate.

It was determined that if bars and restaurants are closed in your State, then your bar and kitchen must also be closed. Some Lodges, located in States which has not ordered the closures, are closing their bar and kitchen anyway, opting for on the side of caution, and that is acceptable. If the bar and kitchen are closed, most States do not prohibit access to the Lodge facility in order to conduct needed services/repair and/or to conduct Lodge business as long as the gathering exceeds the mandated total.

In some cases, where there are closures of the bar and kitchen, a Lodge may still allow Members to access the Lodge, subject to the limitation of the size of gatherings, thereby allowing Members gather in small groups for cards, gaming machines, pull tabs, and other minor activities. If allowed, these Lodges must take extra care to have hand sanitizers available at all entrances and often clean and disinfect high traffic areas. Members who appear ill should be asked to leave the Lodge immediately and to always follow best practices and CDC guidelines. If entry is allowed, it should be restricted to Members Only and no Guests may be invited to the Lodge.

Lodge Grants: Adapting in Response to COVID-19

Due to the COVID-19 pandemic, we're now experiencing a new normal together. In a few short weeks, everything has changed. And, the Community Investments Program must change this year, too. The new CIP grant year set to open on April 1, will likely be delayed to June 1, for all grant components **except** the Gratitude Grant.

With an increasing number of states under shelter-in-place mandates, and many others following the CDC and WHO guidelines—and with the health and wellbeing of Elks communities paramount—we must press pause and let the dust settle before we jump back in to project planning on any scale. With the ability to donate funds to a charitable organization, the Gratitude Grant offers eligible Lodges the perfect opportunity to make a difference when and where it's needed most.

Normally, if a Lodge proposed to donate its Gratitude Grant to another organization, we'd ask to consider a more active use of the funds. Given the COVID-19 pandemic, we're adapting that approach this year. If a Lodge proposes to use a Gratitude Grant for an active project to take place in the next few months, we're going to have a lot of questions about feasibility. Instead, we'll encourage Lodges to think about donating to food pantries or other organizations in the community that are better equipped to directly serve the populations in need as we work our way through this pandemic.

Here are a few causes that could benefit from a Gratitude Grant donation. Your Lodge may identify others. You know your community best.

Feed the Community: Food Banks

As people find themselves unemployed or underemployed, local food banks and food pantries will feel the strain and will have an increased need for donations and supplies. The need will be great and the opportunity to positively and immediately impact the Lodge community is greater. Visit [Feeding America](#) to find your local food bank or food pantry.

The Frontline: Healthcare Workers

We all need to do our part to [#FlattenTheCurve](#) so that hospitals and healthcare workers can continue to do theirs. Hospitals—including V.A. hospitals, medical centers and nursing homes—may find themselves in short supply of life-saving equipment. Consider donating directly to [hospitals in your area](#) that may be working tirelessly to combat this pandemic. If your Lodge focuses on veterans, consider donating directly to a [VA hospital](#) that caters to this population in need during this time.

People Experiencing Homelessness

Support [homeless shelters](#) and assistance programs. For those who don't have anywhere safe to go, this time is even more difficult. Consider donations to programs that will help [vulnerable veterans](#) during this time.

Delaying the launch of the other Lodge grants until at least June 1 will allow us to assess the needs of our communities and figure out the best ways for Elks to help. This may include loosening or reconfiguring grant guidelines prior to the June 1 launch.

We will get through this together. Elks have always shown a tremendous amount of caring, sharing, and grit, and now is no different. As always, the CIP is here to help showcase that #ElksAlwaysCare.

THE PRESIDENT'S CORONAVIRUS GUIDELINES FOR AMERICA

30 DAYS TO SLOW THE SPREAD

Listen to and follow the directions of your **STATE AND LOCAL AUTHORITIES**.

IF YOU FEEL SICK, stay home. Do not go to work. Contact your medical provider.

IF YOUR CHILDREN ARE SICK, keep them at home. Do not send them to school. Contact your medical provider.

IF SOMEONE IN YOUR HOUSEHOLD HAS TESTED POSITIVE for the coronavirus, keep the entire household at home. Do not go to work. Do not go to school. Contact your medical provider.

IF YOU ARE AN OLDER PERSON, stay home and away from other people.

IF YOU ARE A PERSON WITH A SERIOUS UNDERLYING HEALTH CONDITION that can put you at increased risk (for example, a condition that impairs your lung or heart function or weakens your immune system), stay home and away from other people.

THE PRESIDENT'S CORONAVIRUS GUIDELINES FOR AMERICA

DO YOUR PART TO SLOW THE SPREAD OF THE CORONAVIRUS

Even if you are young, or otherwise healthy, you are at risk and your activities can increase the risk for others. It is critical that you do your part to slow the spread of the coronavirus.

Work or engage in schooling **FROM HOME** whenever possible.

IF YOU WORK IN A CRITICAL INFRASTRUCTURE INDUSTRY, as defined by the Department of Homeland Security, such as healthcare services and pharmaceutical and food supply, you have a special responsibility to maintain your normal work schedule. You and your employers should follow CDC guidance to protect your health at work.

AVOID SOCIAL GATHERINGS in groups of more than 10 people.

Avoid eating or drinking at bars, restaurants, and food courts — **USE DRIVE-THRU, PICKUP, OR DELIVERY OPTIONS.**

AVOID DISCRETIONARY TRAVEL, shopping trips, and social visits.

DO NOT VISIT nursing homes or retirement or long-term care facilities unless to provide critical assistance.

PRACTICE GOOD HYGIENE:

- Wash your hands, especially after touching any frequently used item or surface.
- Avoid touching your face.
- Sneeze or cough into a tissue, or the inside of your elbow.
- Disinfect frequently used items and surfaces as much as possible.

School operations can accelerate the spread of the coronavirus. Governors of states with evidence of community transmission should close schools in affected and surrounding areas. Governors should close schools in communities that are near areas of community transmission, even if those areas are in neighboring states. In addition, state and local officials should close schools where coronavirus has been identified in the population associated with the school. States and localities that close schools need to address childcare needs of critical responders, as well as the nutritional needs of children.

Older people are particularly at risk from the coronavirus. All states should follow Federal guidance and halt social visits to nursing homes and retirement and long-term care facilities.

In states with evidence of community transmission, bars, restaurants, food courts, gyms, and other indoor and outdoor venues where groups of people congregate should be closed.
