

## Message from our AEA Elks National Foundation Chairman

#### Support the Elks National Foundation (ENF) - Join the Fidelity Club

The Fidelity Club is an automatic, regularly scheduled donation to ENF, from a bank account or credit card, taken monthly (minimum \$5) or quarterly (minimum \$15). The Fidelity Club is a very easy way for lodge members to support ENF as well as their lodge through the use of ENF grants, especially the Gratitude grant.

The Gratitude grant is awarded to lodges that have met the Grand Exalted Rulers Per-Member donation goal the previous Elk year. ENF has added two \$500 bonuses to the Gratitude grant recognizing member donations online and participation in the Fidelity Club.

A \$500 bonus if, 15% of lodge members donate a minimum of \$10.00 during the elk year and an additional \$500 bonus for lodge's that have at least 15% of their members enrolled in the Fidelity Club. Those lodges that have a 15% member participation in the Fidelity Club will receive both bonuses.

Click the **Monthly Giving** button that will take you to the Fidelity Club page.

Click on **enf.elks.org/recurring** button that will take you to the on-line registration form for the Fidelity Club. Fill out the required fields, click the **Process** button at the bottom of the page, and you're done.

As of August 31<sup>st</sup>, there are only 170 Arizona Elks participating in the Fidelity Club and that equates to just .0064% of the 26,222 members in our state. We can do so much better. It's time to leave the days of yore and embrace the electronic age by donating to ENF on-line. It's quick, easy, and your lodge secretary will love you for it.

I know it is hard to believe, but now is the time to take a serious look at your budget. I know the new Financial Reporting System (FRS) is informing your District Deputies and State Sponsors of what is happening, but it is you as a Lodge Member who should be looking at your budget and realize that your budget percentage should be at 50%.

Is something in your budget out of whack? Are you running way higher than 50%? Then your Board of Trustees/ Directors should take a serious look

at the budget and figure out what to do to make sure that it gets back in line, or how you will make it through the rest of the year. Now, if you are one of the Lodges that rely on your accountant to be doing this for you, then put someone in charge to have a conversation with your accountant and report back to the Lodge or your accountant.

So where is it good to give 100%? Membership! This year's GER Class should be based on the motto, Creating Momentum for the Future of Elkdom. Get out there and recruit Members. But, recruit with the following things in mind:

- The future of Elkdom relies on the age of our Members.
- 2) The future of Elkdom relies on future leaders.
- The future of Elkdom relies on volunteers.
- 4) The future of Elkdom is dependent on us to create new and future Members. Give 100% to the best GER Class ever.

Another place to give 100%: ENF. This is ENF Month and with the raise in the amount of my goal to \$4.80, this is a great time to give 100%. How about giving 100% more than you did last year? This is the year to have an event
